❖ Water Hazard (yellow stakes)	B or E
❖ Lateral water hazard (Red stakes)	B,D or E
❖ Hit wrong ball	A or M
❖ Grounding club in a hazard	A or M
❖ Giving /asking advice	A or M
❖ Abnormal ground conditions (casual water, GUR, animal holes etc.)	F
❖ Artificial obstruction – interferes with stance, swing or lie.	F
❖ Ball hits self/equipment	N
❖ Ball at Rest moved <u>when on the green</u> ----by player accidentally	R
----By an outside agency (wind etc.)	S
❖ Ball at Rest moved <u>when though the green</u> ----by player accidentally	B
----by an outside agency	R
❖ Incorrect tee box or outside tee area	P or Q

Penalties & Options

A	Two strokes penalty
B	Replay from original lie one stroke penalty
C	Drop within two club lengths one stroke penalty
D	Drop within two club lengths of where the ball last crossed hazard margin, no closer to the pin one stroke penalty
E	Drop as far back as you like on a line to the hole where the ball last passed the hazard margin OR where unplayable ball lies one stroke penalty
F	Nearest point of complete relief PLUS one club length – no penalty
M	Loss of hole in match play
N	One stroke penalty
O	No penalty
P	Stroke play – must replay ball two strokes penalty
Q	Match play – no penalty, but opponent may require player to replay from the correct tee box area
R	Replace in original lie – no penalty
S	Play from new location – no penalty
